

**AMENDMENT OF CCR'S
ANNEXATION OF ADDITIONAL PROPERTY**

THE CAPES NO. 5, in Tillamook County, Oregon, as disclosed by Subdivision Plat recorded March 15, 1995, in Plat Cabinet "B-0", Slide 430, Tillamook County Plat Records.


